Alternatives- You Choose

- Alternative 1 : No action/no new development
- Alternative 2 (GTR's proposed action): Full approval of GTR's request:
 - South Bowl Expansion (266 acres): 60 acres of new ski runs, access road, ski lift, ski patrol building, vault toilet, rescue cache, & two avalaunchers.
 - Mono Trees Expansion (600 acres): 97 acres of new ski runs, access roads, ski lift, & mountaintop cabin.
 - Additional proposed projects within current boundaries: Upgrades to 2 lifts, 4 new lifts, 214 new acres of ski runs, 550 new acres of glading, expanded snowmaking (57 acres), 5 new guest facilities (Fred's Mountaintop restaurant), tubing facility, nordic/snowshoe/fat bike trails, 29 new miles of summer trails, and a "summer activity zone" with zip lines and aerial courses.
- Alternative 3: No Expansion + Approve all proposed projects within current boundaries.
- Alternative 4: South Bowl Expansion + Approve all proposed projects within current boundaries.

Alternatives- You Choose

- Alternative 1 : No action/no new development
- Alternative 2 (GTR's proposed action): Full approval of GTR's request:
 - South Bowl Expansion (266 acres): 60 acres of new ski runs, access road, ski lift, ski patrol building, vault toilet, rescue cache, & two avalaunchers.
 - Mono Trees Expansion (600 acres): 97 acres of new ski runs, access roads, ski lift, & mountaintop cabin.

- Alternative 3: No Expansion + Approve all proposed projects within current boundaries. + MODIFICATIONS
- Alternative 4: South Bowl Expansion + Approve all proposed projects within current boundaries.
- Alternative 5: Mono Trees Expansion + Approve all proposed projects within current boundaries.

Ways in which the Proposed Action conflicts with Targhee Forest Plan

- Removes **scenery protections** for South Bowl and Mono Trees.
- Supersedes forest plan protections for **aquatic resources** in South Bowl and Mono Trees.
- Tree clearing and construction activities within the Mono Trees expansion area contradicts standards for **goshawk habitat**.
- The forest plan prohibits tree clearing within 30-acres of a **flammulated owl** and **boreal owl** nests. Tree clearing is proposed within all of 5 flammulated owl nesting areas within the existing SUP. There is a boreal owl nest in the Mono Trees area and another within Targhee's existing SUP. The majority of the Mono Trees boreal owl nest area (24.1 acres) would be gladed or clearcut for ski terrain. A small amount (1.1 acres) of the other nest area would impacted.
- The forest plan restricts human disturbances from March 15 through July 31 to avoid adverse impacts at known falcon nest sites. Proposed activities across all action alternatives are within 2 miles of 2 known **peregrine falcon** eyries in Teton Canyon but expansion into South Bowl would have the greatest impact on peregrine falcons because of the proximity to the eyries
- New development adjacent to the **Jedediah Smith Wilderness** conflicts with forest plan directives (*Maintaining the natural diversity of wildlife species is the highest priority*) and threatens opportunities for solitude and unconfined recreation within the JSW as mandated by the Wilderness Act of 1964



From a Forest Supervisor's perspective...

Organizational influences:

- Ski industry lobby is strong
- USFS has 'bias for action'

What the decision-maker considers:

- Need for the proposal
- Current Forest Plan direction
- Impacts on the environment (wildlife, water, wilderness, etc.)
- Impacts on the culture, economy, and infrastructure of adjacent communities
- Assuming this decision will be challenged, what decision can USFS defend?





The most powerful comments:

- Connect your opinion with existing laws, regulations, plans (including county/municipal plans), research, etc.
- Point out specific issues/deficiencies with the DEIS
- Clearly state your position Ex. "I do not approve / I approve...."



Growth of Backcountry Skiing

- "Alpine touring 2nd fastest growing sport in the U.S. with a 115% participation growth the past 4 years."
 - Increasingly crowded backcountry trailheads
 - AIARE avalanche courses: annual average of 11,325 participating (2023-2025)
 - \circ Increase in gear sales





Socio-economic Impacts:

- Housing
- Labor supply
- Public services



GTR Base Area Development:

- 120-acre private inholding
- Increased units (96 to 450)
- Increased commercial (37,000 sf to 150,000 sf)
- Increased occupancy (3,000 gpd to 6,200 gpd)
- Application submitted to TCWY



2022 ECONorthwest Study Conclusions:

- Timing and pace of GTR development will determine severity of impacts.
- Teton County, ID government would see "only costs."
- City of Driggs infrastructure needs would "far outweigh" any increased lodging sales tax increases.
- Visitor & employee demand would exacerbate existing housing shortage.



2022 ECONorthwest Study Recommendations:

- Cost Share
- Fire / EMS Contracts
- Broad affordable housing strategies
- Coordination with GTR on phasing timing of development



From DEIS Executive Summary:

- The purpose of, and need for, the Forest Service's action is to <u>decide whether to grant a special use permit</u> (SUP) for the project.
- The CTNF will consider the application for use of NFS lands and determine if the project is in the public interest and is appropriate.

From DEIS section 1.3 Purpose and Need:

• Grand Targhee identified a need to improve the recreational experience and address shortcomings in their terrain offerings and operations in order to remain viable in the competitive destination skier/rider market.




GTR Current Special Use Permit - Current Conditions




GTR Proposed Expansion Areas




GTR Proposed Lifts (red)




GTR Proposed Glading

Wildlife Impacts of a South Bowl Expansion

Eliminate critical secure habitat for grizzly bears, increasing human-bear conflicts, and raising the risk of bear mortalities.

Wolverines will lose expansive denning habitat in South Bowl. Whitebark Pine - over 11 acres mid-high density will be removed. The vulnerable and declining Teton Bighorn sheep herd will lose valuable habitat and access to rare mineral lick, compromising the population.

Peregrine falcon nests and nesting habitat will be disrupted.

Wildlife Impacts of a Mono Trees Expansion

Canada lynx will lose over 200 acres of habitat in Mono Trees expansion.

Expansion requires a rezoning of both South Bowl and Mono Trees. Let's not privatize our precious public lands.

Water Impacts: POWJH

- 57 acres of snowmaking = 23 million gallons of water
- 179 acres of wetlands impacts
- Risk of pollution to Mill Creek, Teton River, and local drinking water

Proposed tree clearing and lift installation will impact many protected species. Forest Plan amendments will be needed for actions that will disturb:

- American goshawks
- Boreal owls
- Flammulated owls
- Three-toed woodpeckers
